

# CAN/BNQ 3680-600

Our associates, DBO Expert is pleased to announce that after spending fifteen months on a bench-test in Quebec City in 2017-18, the Enviro-Septic System is now certified by the BNQ (Bureau de normalisation du Québec – Quebec standards bureau) under the Canadian Onsite Residential Wastewater Treatment Technologies standard (CAN/BNQ 3680-600).

This certification is one of many the Enviro-Septic System technology has acquired over the years, including in Quebec (CAN/BNQ 3680-910 standard), in the United States (NSF 40 standard) and in Europe (NE12566-3 standard).

The Enviro-Septic System technology focus on the natural treatment of wastewater, mimicking the way Nature intended. Ecological and long-lasting, these solutions are also cost-effective, require no electricity, no regular maintenance nor replacement of any component (except OBC mandated yearly inspection), and represent worry-free solutions for septic systems.

The CAN/BNQ 3680-600 standard requires twelve months of bench-testing at a BNQ-accredited facility in both hot and cold weather, fully representative of the Canadian climate. The certification program is accredited by the Standards Council of Canada.
